Dear Legislator:

I am pleased to provide you with a comprehensive summary of economic assistance programs sponsored by the Ohio Department of Development (ODOD) for the period beginning January 01, 2003 and ending December 31, 2003.

This report will provide you with the opportunity to review ODOD's ongoing pursuit to foster economic growth, payroll creation and retention, and community development throughout our great State of Ohio. Each incentive "package" is assigned to one of three distinctive categories based on the type of assistance approved for a business or local community. The three classes are:

DIRECT ASSISTANCE TO BUSINESS, which includes direct ODOD financial assistance for business attraction and expansion projects entailing job creation, job retention, and workforce training.

INDIRECT ECONOMIC ASSISTANCE, which encompasses funding programs that improve a business or local entity's competitiveness but are not measurable in terms of immediate employment increases. These programs, some of which are mandated by the federal government and administered by ODOD, generate long-term economic benefits for the state that should not be subject to short-term quantitative criteria, such as job creation and retention.

COMMUNITY ASSISTANCE, which identifies financial assistance targeted at quality-of-life enhancements at the local level. Typically offered as grants and loans, the majority of these programs are federally funded, with all administrative responsibilities by ODOD.

Please understand that the reported job creation and retention numbers represent projections to which respective companies have committed in order to receive funding approval from ODOD and other state boards. Companies have been afforded three years in which to fulfill their commitments. Economic conditions occasionally precipitate adjustments in stated commitment figures.

I hope that you will find this report to be helpful. As always, ODOD welcomes your input in our quest to provide you with valuable statistical information on our many programs.
